
Schedule

The Commissioners have requested certain changes be made to the typical schedule adopted for rate case proceedings. The requested changes include that:

- Evidentiary hearings be scheduled at least three months prior to the end of the suspension period.
- Prior to hearing, the parties file a Hearing Memorandum, limited to 15 pages, that summarizes the facts, issues, and arguments of the case.
- After hearing, the parties file sequential briefs as follows:
 - Utility Opening Brief, limited to 35 pages
 - Staff and Intervenor Response Briefs, limited to 35 pages
 - Utility Reply Brief, limited to 15 pages.
