RE: Advice No. 14-7

On May 5, 2014, Northwest Natural filed revised sheets for inclusion in its tariff, PUC OR No. 25. On May 21, 2014 an extension of the effective date was filed. Subsequent extension requests were also filed on July 14, July 23, and September 11, 2014. On September 26, 2014 two supplemental filings were made along with an application to Waive Less than Statutory Notice. On September 30, 2014 an additional supplement along with an additional application to Waive Less than Statutory Notice were filed. On October 2, 2014 a final replacement filing was made.

This filing adds Schedules 90 and 91 for Firm Storage Service with No-Notice Withdrawal, and Firm Storage Service with No-Notice Withdrawal and Direct Connection to South Mist Pipeline.
