Dear Commissioners:

Pursuant to Qwest Corporation's d/b/a CenturyLink QC Price Plan under ORS 759.255 approved by the Commission in Order No. 14-346 in Docket No.UM 1354, the Company initially made this filing on March 9, 2015 to transfer a number of services from its Exchange and Network Services Tariff to its Price List. Supplement No. 1 delayed the original proposed effective date of April 11, 2015 to May 9, 2015 due to a customer notification issue. **Supplement No. 2 requests an additional delay to the effective date for only the rate increases, due to the same customer notification problem.** This filing also revises Section 1, Sheet 15 to include Call Line Identifier in the Index. Call Line Identifier (Advice No. 2123) became effective on March 13, 2015. In conjunction with this Tariff filing, CenturyLink also filed the companion filing early which provided the changes to the Qwest Corporation Price List. A supplemental filing will follow for the Price List pages as well.

Specifically, the Company attaches its modified Qwest Corporation d/b/a CenturyLink QC Exchange and Network Services Tariff No. 33 pages. Attachment A, following, lists the sheets included in this filing, as well as specific information regarding revisions to individual sheets in Tariff.

Generally, unless otherwise noted below, services are being transferred from the Tariff to the Price List without any substantive changes. Statements have been added to the Tariff to provide references that indicate the services that have been moved to the Price List. As a result of the moves of services from the Tariff to the Price List, the Company has made revisions to indices.

This filing includes rate increases as allowed under the Price Plan. In addition, Sheets 21 through 29 in Section 14 were moved to the Price List in November 2008, but the pages were inadvertently left in the Tariff so are now being deleted. Section 16 is being removed in its entirety as the remaining promotions are obsolete and no longer available to customers. Finally, Farmer Line Service, which was grandfathered December 31, 2007, is being withdrawn as there are no longer any customers subscribing to the service. The proposed effective date of this filing is now June 9, 2015.

2.3.2 PAYMENT OF BILLS (Cont'd)

J. In deciding on the reasonableness of a particular agreement, the Company will take into account the customer's ability to pay, the size of the unpaid balance; the customer's payment history and length of service, and the amount of time and reasons why the debt is outstanding.

1. A late payment charge will apply to accounts not paid in full each month and leaving an unpaid balance of \$30.00 or more to be carried forward.
2. The late payment charge will be listed separately and included in the total amount due on the current bill.
3. The minimum late charge is \$0.50.
4. The rates of interest paid will be established annually by the Oregon Public Utility Commission, in accordance with Oregon Administrative Rule (OAR) 860-21-126.
5. In accordance with OAR 860-21-126(3) and OAR 860-34-120(2), the applicable monthly interest rate will be established annually by the Oregon Public Utility Commission.
