Comcast Corporation & Subsidiaries (“Comcast”) hereby submits the enclosed *amended* Qualified Project Determination Application (the “Amended Application”) to correct certain parts of Comcast’s Qualified Project Determination Application filed on January 13, 2016. Please note that Comcast supplied corrections in response to the Commission Staff’s information requests of January 22, 2016; however, per the Commission Staff’s request, Comcast is submitting this Amended Application.

The Amended Application corrects the following parts of Comcast’s original application:

- The zip file referenced in the response behind Tab 4B in the original application contained certain extraneous data (“snow”). The zip file referenced in the response behind new Tab 4C in the Amended Application omits this data. Please note that this data is not visible in the map provided behind Tab 4A in the original application.
- The responses behind Tabs 6A and 6B, and the Excel files referenced therein, were inadvertently transposed in the original application. In the Amended Application, the responses have been swapped and the Excel files referenced therein have been renamed accordingly.
- The “infrastructure topology” depicted in the response behind Tab 10A in the original application contained a typographical error. That error has been corrected in the response behind Tab 10A in the Amended Application.

With the exception of the above corrections, the Amended Application is identical in all respects to Comcast’s original application.

As with Comcast's original application, portions of the Amended Application are confidential and protected from public disclosure under federal and/or state law, including, but not limited to, ORS 192.502(8) and 192.501(2). For this reason, we have enclosed two separately bound sets of documents:

- The first bound set of documents is an unredacted copy of the Amended Application in which all confidential information has been identified as such and printed on yellow paper pursuant to OAR 860-001-0070.
- The second bound set of documents is a copy of the Amended Application in which all confidential information has been redacted.

The numbered tabs in the bound sets generally correspond to the appropriate section of OAR 860-200-0150. We have enclosed two flash drives, the first of which contains an electronic, unredacted copy of the Amended Application, and the second of which contains an electronic, redacted copy of the Amended Application

Enclosed please find the Qualified Project Determination Application (the "Application") of Comcast Corporation & Subsidiaries (collectively "Comcast"), which we are submitting pursuant to Oregon Laws 2015, Chapter 23 and OAR 860-200-0100. Also enclosed is a check (No. 210039612) in the amount of \$50,000, made payable to the Public Utility Commission of Oregon, which covers the application fee required by Section 5(3)(b)(B) of Chapter 23, Oregon Laws 2015 and OAR 860-200-0100. In accordance with OAR 860-200-0100(2)(C), and as evidenced in the enclosed certificate of service, we are contemporaneously overnighting a copy of this letter and the enclosed Application to the Valuation Section, Property Tax Division, of the Oregon Department of Revenue.

The enclosed Application is comprised of an "Application Cover Sheet, Section 5 Chapter 23 OL 2015 Application, OAR 860-200-0100," along with all of the documents and information required by OAR 860-200-100 through 860-200-0150. Portions of the Application are confidential and protected from public disclosure under federal and/or state law, including, but not limited to, ORS 192.502(8) and 192.501(2). For this reason, we have enclosed two separately bound sets of documents:

- The first bound set of documents is an unredacted copy of the Application in which all confidential information has been identified as such and printed on yellow paper pursuant to OAR 860-001-0070.
- The second bound set of documents is a copy of the Application in which all confidential information has been redacted.

Please note that the numbered tabs in the bound sets generally correspond to the appropriate section of OAR 860-200-0150. We have enclosed two flash drives, the first of which contains an electronic, unredacted copy of the Application, and the second of which contains an electronic, redacted copy of the Application.

We also wanted to take this opportunity to provide additional information in support of the Application. Comcast provides video, high-speed data and phone services in thirty-nine states, including Oregon. Comcast provides communication services in ten Oregon counties: Benton, Clackamas, Columbia, Lane, Linn, Marion, Multnomah, Polk, Washington and Yamhill. Comcast offers “Gigabit Pro,” a tier of internet access service delivering download and upload speeds of up to two gigabits per second symmetrical in a number of markets in twenty-seven states, including California, Florida, Illinois, New York, Texas and Washington. Comcast began offering Gigabit Pro in and around Beaverton, Corvallis, Damascus, Eugene, Forest Grove, Gladstone, Gresham, Happy Valley, Hillsboro, Junction City, Lake Oswego, McMinnville, Milwaukie, Oregon City, Portland, Salem, Tigard, West Linn and Wilsonville prior to December 31, 2015.

Turning to the Application itself, OAR 860-200-0150(3) requires every applicant to submit a written commitment “that when its network depends in part or wholly on a third party to provide the qualified service, the applicant will use commercially reasonable practices to ensure that the use of any third party will not impede the performance of the project’s infrastructure in providing the applicant’s qualified service.” Comcast’s written commitment is enclosed behind Tab 3 in each bound set of documents; however, it should be noted that Comcast has network plant in all of its Oregon franchise areas and, as such, does not depend “wholly” on third parties to provide Gigabit Pro.

Section 5(2)(b) of Chapter 23, Oregon Laws 2015 provides that to qualify for the treatment specified in Section 5(5) of Chapter 23, Oregon Laws 2015, an applicant cannot “deny access to the communication services to any group of residential customers because of the income level of the residential customers in the local service area in which the residential customers reside.” In order to provide communication services in Oregon, Comcast is required to enter into a franchise agreement with the local franchising authority of each franchise area it serves. Each franchise agreement establishes the obligations Comcast must meet in order to operate (and continue operating) a cable system in the franchise area.

Most, if not all, of Comcast’s franchise agreements with Oregon franchising authorities contain anti-discrimination provisions. For example, Comcast’s franchise agreement with the City of Portland provides, in relevant part:

8.1 Non-Discriminatory Rates and Charges. Grantee shall provide Cable Services to all Subscribers in the Franchise Area under non-discriminatory rates and reasonable terms and conditions. Grantee shall not arbitrarily refuse to provide Cable Services to any Person within the Franchise Area, in accordance with Section 10.6.

....

10.6 Rate Discrimination. All Grantee Residential Subscriber rates and charges shall be published and non-discriminatory as to all Persons and organizations of similar classes, under similar circumstances and conditions. Grantee shall establish similar rates and charges for all

Residential Subscribers receiving similar services, regardless of race, color, religion, age, sex, marital or *economic status*, national origin, sexual orientation, physical or mental disability, *income of the residents*, or geographic location within the Grantee's Franchise Area.

.....

10.10 Discriminatory Practices. Grantee shall not deny Cable Service, or otherwise discriminate against Subscribers, Programmers or any other Persons on the basis of race, color, religion, age, sex, national origin, sexual orientation or physical or mental disability. Grantee shall comply at all times with all other applicable federal, state or local laws, rules and regulations relating to non-discrimination.

City of Portland, Or., Ordinance No. 185112 §§ 8.1, 10.6, 10.10 (emphasis added) (granting franchise to Comcast of Oregon II, Inc.).

Comcast complies with anti-discrimination requirements like those above with respect to its cable services and, as a matter of practice, follows the same requirements with respect to its high-speed data services. Accordingly, Comcast does not deny access to Gigabit Pro (or any other communication services) to any group of residential customers based on the income level of the residential customers in the local service area in which the residential customers reside.



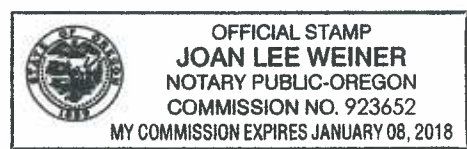
