The Oregon Citizens' Utility Board (CUB) files this Notice of Intent to Request Issue Fund Grant in UE 314, pursuant to OAR 860-012-0100(3)(a) and the Idaho Power - CUB 2016 -2020 Intervenor Funding Agreement (IFA), approved by the Oregon Public Utility Commission (Commission) in Order No. 16-028 (January 26, 2016).

1. The Public Utility Commission of Oregon has opened a docket to investigate Idaho Power's power supply expenses, based on its October and March forecasts. The Commission will examine Idaho Power's rate adjustments in this filing in Docket No. UE 314.
2. UE 314 is an Eligible Proceeding under the IFA. The IFA defines an Eligible Proceeding as "any Commission proceeding that directly affects Idaho Power including, but not limited to, rulemaking proceedings, declaratory ruling proceedings, and contested case proceedings, but does not include complaint proceedings if CUB initiates or causes to be initiated the complaint proceeding." IFA, Article 1(b).
3. UE 314 will directly affect Idaho Power, which is a Participating Public Utility under Article 1(h) of the IFA.

4. As required by IFA Article 6.2, this Notice of Intent is being served on each affected Participating Public Utility, all pre-certified organizations, and all parties identified on the service list from UE 314.<sup>1</sup>
5. CUB identifies the 2017 Idaho Power Issue Fund Account as the account from which CUB intends to request the Issue Fund Grant.
6. CUB has been pre-certified under Article 5.1 of the IFA and OAR 860-001-0120(3)(a), as eligible to receive an Issue Fund Grant.
7. CUB will file a proposed budget with respect to the Issue Fund Grant, as provided in Article 6.3 of the IFA.
