**STAFF RECOMMENDATION:**

Staff recommends that the Commission allow the February 28, 2017 filings by CenturyTel of Oregon, Inc. (Docket No. ADV 525/Advice No. OR17-01A) and United Telephone Company of the Northwest (Docket No. ADV 525/Advice No. OR17-02A), which revise their Late Payment and Deposit Interest rates and intrastate tariff language for Intrastate Access Service, effective April 1, 2017, to go into effect.

**DISCUSSION:**

On February 28, 2017, CenturyLink filed advices for its companies' access tariffs to be effective April 1, 2017. The filings propose to change the late payment language and penalty to 0.0407% per day (a 16.01% annual rate). The deposit interest rate language was revised to reference the late payment penalty for the interest rate paid on deposits. The intrastate access tariffs to be revised are CenturyTel of Oregon Inc. Oregon P.U.C. AC4 and United Telephone Company of the Northwest PUC Or. No. 6.
