



Program Administrator’s Project Recommendation

May 18, 2022

Community Solar Program - Docket No. UM 1930

On January 11, 2022, in Order No. 22-007, the Commission permitted the delegation of Commission authority to the Community Solar Program Administrator (PA) to grant noncontroversial project pre-certifications, waivers, extensions, and amendments. Under the permitted delegation of authority, Staff will post the PA’s project recommendation to UM 1930 with a comment period of two weeks. If no comments in opposition are received prior to the end of the comment period, the recommendation will go into effect. If comments in opposition are received prior to the end of the comment period, the recommendation will not go into effect and the matter will be referred to the Commission for a decision at the next available public meeting.

Sulus had previously advised the Program Administrator that it intended to complete early-stage development activities on the projects it manages and then sell its portfolio, and that the pending sale of its portfolio to SolRiver was contingent on the pre-certification of its Tier 2 projects. The Program Administrator notes that it is common in the solar industry for projects to be sold during the development process and for solar developers to specialize in certain project development stages. SolRiver has not yet designated a subscription manager for these projects and will be asked to prior to beginning customer enrollment. As customer enrollment has not begun for these projects, no customers will be impacted by this sale and transfer. Because of those factors, the Program Administrator has no objections to or concerns with this sale and transfer.
