



Program Administrator's Project Recommendation

April 26, 2022

Community Solar Program - Docket No. UM 1930

On January 11, 2022, in Order No. 22-007, the Commission permitted the delegation of Commission authority to the Community Solar Program Administrator (PA) to grant noncontroversial project precertifications, waivers, extensions, and amendments. Under the permitted delegation of authority, Staff will post the PA's project recommendation to UM 1930 with a comment period of two weeks. If no comments in opposition are received prior to the end of the comment period, the recommendation will go into effect. If comments in opposition are received prior to the end of the comment period, the recommendation will not go into effect and the matter will be referred to the Commission for a decision at the next available public meeting.

Staff posts the PA's recommendation to grant project pre-certification for the following projects:

PGE-2021-94 (Canyonville Solar 1) PGE-2021-142 (Canyonville Solar 2)

The Project Manager (PM) initially submitted a single pre-certification application for both projects listed above to the Community Solar Program (Program) waitlist for the PacifiCorp service area. At that time, the Program allowed PMs to treat multiple co-located projects as a single project if the aggregated capacity did not exceed 3 MW-AC. However, the Program disallowed this in January 2022 after discovering it unintentionally caused problems with the Program's data transfer system.

The Program recently allowed the PM to resubmit separate pre-certification applications for the two projects, with both applications maintaining the same relative placement in the waitlist. This was allowed because the PM complied with Program rules when it first submitted a single pre-certification, the January 2022 rule change was only because of a data transfer issue unrelated to the waitlist or project pre-certification process, and because it would not negatively impact the pre-certification of projects further down the waitlist. Staff finds these reasons and the PA's recommendation to be noncontroversial and that granting pre-certification may be delegated to the PA. Stakeholders in opposition of the PA's recommendation should post comments to UM 1930 by May 10, 2022.
