APPLICATION

I. INTRODUCTION

9 Pursuant to ORS 757.259, ORS 757.365, OAR 860-027-0300, OAR 860-084-0380
10 and -0390, Idaho Power Company ("Idaho Power" or "Company") hereby requests an
11 accounting order reauthorizing Idaho Power to defer revenues collected through the
12 Company's Tariff Schedule 93 – Solar Photovoltaic Pilot Program Rider ("Solar PV Program
13 Rider") and expenditures associated with the implementation and administration of the Solar
14 Photovoltaic Pilot Program, which is set forth in Schedule 88 – Solar Photovoltaic Pilot
15 Program ("Pilot Program"). Idaho Power seeks reauthorization of this deferral effective as of
16 October 1, 2019. In support of this Application, Idaho Power states:

II. OAR 860-027-0300(3) REQUIREMENTS

2

A. Description

3 ORS 757.365 (2009), as amended by House Bill 3690 (2010), mandated the
4 development of pilot programs for each electric company to demonstrate the use and
5 effectiveness of volumetric incentive rates and payments for electricity delivered by solar
6 photovoltaic energy systems. The legislation authorized the Commission to establish
7 incentive rates for the pilot programs to enable the development of the most efficient solar
8 photovoltaic systems. As such, in Docket No. UM 1452, and approved with Order No. 10-
9 198, the Commission established the Pilot Program to demonstrate the use and effectiveness
10 of volumetric incentive rates ("VIR") payments for electricity or for the non-energy attributes
11 of electricity, or both, delivered from a solar photovoltaic system permanently installed by
12 retail electric customers. The Commission allocated 0.4 megawatts of the Pilot Program
13 capacity to Idaho Power and specified it was to be allocated only to residential qualifying
14 systems.¹

15 The Commission approved Idaho Power's Solar PV Program Rider effective July 1,
16 2010.² The Solar PV Program Rider is a balancing account mechanism that charges
17 customers a percentage of the sum of the monthly charges for the base rate components of
18 their electric bill. Base rate components include the service charge, energy charges, demand
19 charges, and the basic charge. Revenues received from the Solar PV Program Rider fund
20 the implementation and administration of the Pilot Program and are recorded in a regulatory
21 liability account. As funds are used for administration of the program and VIR payments, the
22 balancing account is debited for the amount of the expenditure disbursement.

1 With this deferral application, Idaho Power seeks reauthorization from the Commission
2 to defer, for future true-up, Solar PV Program Rider revenues and Pilot Program
3 expenditures. In addition, the Company requests that the Commission determine that
4 amortization of this deferral does not require an earnings review because it is subject to an
5 automatic adjustment clause under ORS 757.210(1). This treatment is consistent with the
6 cost recovery provisions in ORS 757.365(10) and OAR 860-084-0380, and the cost recovery
7 mechanisms approved for Portland General Electric Company³ and Pacific Power⁴ for the
8 implementation of their Pilot Programs.

9 **B. Reasons for Deferral**

10 ORS 757.365(10) and OAR 860-084-0380 provide that all prudently incurred costs
11 associated with the Pilot Program are recoverable in rates. In Order No. 10-198, the
12 Commission authorized Idaho Power "to recover 100 percent of its costs through a rider
13 mechanism."⁵ This deferral will capture the difference between the revenues received
14 through the Solar PV Program Rider (*i.e.*, the rider mechanism authorized in Order No. 10-

1 198⁶) and the actual costs of the Pilot Program, thereby ensuring that Idaho Power recovers
2 100 percent of its costs—no more and no less.

3 **C. Proposed Accounting**

4 Idaho Power records revenues and expenses that would be subject to the deferral
5 order in accordance with the Code of Federal Regulations to the Federal Energy Regulatory
6 Commission Account 254 (Regulatory Liability).

7 **D. Estimate of Amounts**

8 As of August 31, 2019, the Oregon jurisdictional Solar PV Program Rider balance was
9 approximately \$144,000. The Company estimates net amounts deferred beginning the date
10 of this Application through August 2020 to be approximately \$30,000, for a total balance of
11 approximately \$173,000.

12 **E. Notice**

13 A copy of the Notice of Application for Deferred Accounting of Solar Photovoltaic Pilot
14 Program Revenues and Expenditures and a list of persons served with the Notice are
15 attached to the Application as Attachment A.

16 **III. OAR 860-027-0300(4) REQUIREMENTS**

17 **A. Entries in the Deferred Account to Date**

18 Attached to the Application as Attachment B is a description and explanation of the
19 entries in this deferred account from January 1, 2018, through August 31, 2019. At the
20 December 18, 2018, public meeting, the Commission approved the reduction in the Solar PV
21 Pilot Program Rider from 1.5 percent of base revenues to 0.5 percent and also approved the
22 transfer of \$5.5 million in Solar PV Program Rider funds to Idaho Power's Energy Efficiency

1 Rider account, thereby reducing the Solar PV Program Rider fund balance and better aligning
2 revenue collections with the Company's Solar PV Program expenditures. Both items are
3 reflected in Attachment B.

4 B. Reason for Continuation of Deferred Accounting

5 Idaho Power is seeking approval to continue the Solar PV Program Rider deferral as
6 described in Section II above.

7 IV. CONCLUSION

8 Continued Commission approval of the ongoing operation of the Solar PV Program
9 Rider balancing account is consistent with the Commission direction in Order No. 10-198.
10 For the reasons stated above, Idaho Power requests reauthorization to defer revenues
11 collected through the Solar PV Program Rider and expenditures associated with the
12 implementation and administration of the Pilot Program, beginning October 1, 2019, and that
13 those deferred amounts are exempt from an earnings test.
