

1. In accordance with the all-party stipulation approved in this docket in Order No. 19-304, on September 16, 2019, PacifiCorp d/b/a Pacific Power (PacifiCorp), filed tariffs to update the Renewable Adjustment Clause (Schedule 202) to recover the revenue requirement associated with its investment in repowering certain wind facilities. PacifiCorp made a compliance filing to update the Renewable Adjustment Clause on December 19, 2019, and now files this attestation from the Chief Executive Officer of Pacific Power, certifying that Goodnoe Hills and High Plains have been placed in service and are operational.


