**MOTION TO AMEND  
THE STIPULATION**

**INTRODUCTION**

2           PacifiCorp d/b/a PacifiCorp (PacifiCorp) respectfully requests the Public Utility  
3 Commission of Oregon (Commission) for permission to amend the stipulation filed on  
4 August 1, 2019. In the process of updating the costs consistent with the terms of the  
5 stipulation, PacifiCorp discovered a typographical error, and now seeks to correct that error  
6 with this motion. PacifiCorp has conferred with the Staff of the Public Utility Commission of  
7 Oregon (Staff), the Oregon Citizens' Utility Board (CUB), the Alliance of Western Energy  
8 Consumers (AWEC), Calpine Energy Solutions LLC (Calpine Solutions), and the Small  
9 Business Utility Advocates (SBUA), (collectively the Stipulating Parties) and the Stipulating  
10 Parties support this motion.

**PROPOSED MODIFICATION**

11  
12 To correct the typographical error in the stipulation, PacifiCorp proposes the following  
13 adjustment. The updated language is highlighted in bold:

14       **22. Updated Costs:** PacifiCorp intends to file final cost updates one month in advance of  
15 the October 1 and December 1 rate effective dates (i.e., on September 1 and  
16 November 1, respectively). If the updated costs in a specific facility are lower than  
17 those reflected in **Attachment A, Settlement PAC 401**, the updated costs will be

1 used to set rates. If the updated costs have not changed or are higher, rates will be set  
2 using the costs in **Attachment A, Settlement PAC 401**. If the updated costs are  
3 higher, PacifiCorp reserves its rights to seek recovery of the cost increase in its next  
4 general rate case or RAC filing, as authorized by ORS 469A.120(2), and all other  
5 Stipulating Parties may challenge any such request.


6 PacifiCorp filed updated costs on September 3, 2019, that reflected lower costs than those in  
7 Attachment A, Exhibit 401. As a result the updated costs from the September 3, 2019 will be  
8 used to set rates on October 1, 2019 if the Stipulation is adopted by the Commission.

### 9 CONCLUSION

10 For the reasons described in this motion, PacifiCorp respectfully requests the Commission  
11 accept the modifications proposed in this motion in order to correct this typographical error.
