
PACIFICORP'S MOTION TO MODIFY  
PROCEDURAL SCHEDULE  
**(Expedited Consideration Requested)**

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp) respectfully requests that the Public Utility Commission of Oregon (Commission) issue an order amending the procedural schedule in this docket to extend the deadline for PacifiCorp's Surrebuttal testimony from June 24, 2019 to June 26, 2019 in order to continue settlement discussions. Because PacifiCorp's Surrebuttal testimony is due June 24, 2019, PacifiCorp requests expedited treatment of this motion in accordance with OAR 860-001-0420(6). PacifiCorp has contacted all the parties and the Staff of the Public Utility Commission of Oregon (Staff), the Oregon Citizens' Utility Board (CUB), the Alliance of Western Energy Consumers (AWEC), and Calpine Energy Solutions LLC (Calpine Solutions) do not oppose this motion. PacifiCorp has not yet heard back from the Small Business Utility Advocates.

PacifiCorp is currently working with parties and can represent that substantial progress has been made in discussions for a settlement. Providing two additional days for PacifiCorp to file testimony will allow the parties to fully explore this opportunity for settlement, while still allowing parties to prepare for a hearing if necessary. PacifiCorp is not requesting to modify any other dates in the procedural schedule at this time; however, if it becomes necessary to file testimony, PacifiCorp commits to making a good faith effort to respond by the morning of July 3<sup>rd</sup> to any discovery issued on or before June 27<sup>th</sup> in response to its final round of testimony to

provide parties with an opportunity to include any such responses as cross-examination exhibits.
