

PACIFICORP'S MOTION TO SUSPEND  
THE PROCEDURAL SCHEDULE  
**(Expedited Consideration Requested)**

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp) respectfully requests that the Public Utility Commission of Oregon (Commission) issue an order suspending the procedural schedule in this docket in order to continue settlement discussions. Because PacifiCorp's Surrebuttal testimony is due June 26, 2019, PacifiCorp requests expedited treatment of this motion in accordance with OAR 860-001-0420(6). PacifiCorp has contacted all the parties and the Staff of the Public Utility Commission of Oregon (Staff), the Oregon Citizens' Utility Board (CUB), the Alliance of Western Energy Consumers (AWEC), and Calpine Energy Solutions LLC (Calpine Solutions) do not oppose this motion. PacifiCorp has not yet heard back from the Small Business Utility Advocates.

PacifiCorp is currently working with parties and can represent that substantial progress continues to be made in discussions for a settlement, and parties have agreed that a suspension of the procedural schedule is appropriate at this time. If parties fail to reach a settlement, then Commission will be informed, and parties will work with the administrative hearings division to set a revised procedural schedule. PacifiCorp respectfully requests that the Commission grant this motion.
