STIPULATED MOTION TO ADOPT
PROCEDURAL SCHEDULE

9 Pursuant to OAR 860-001-0420(2) and Administrative Law Judge (ALJ) Allwein’s May
10 27, 2020 Ruling, Staff of the Public Utility Commission of Oregon (Staff) respectfully moves
11 ALJ Allwein for a ruling on the procedural schedule in this docket.

12 Upon further discussion and consideration by the parties to this proceeding,¹ the parties
13 request that prior to convening a contested case process in Phase II, a Commissioner workshop
14 be scheduled. The parties anticipate the purpose of the workshop would be to identify areas of
15 consensus, highlight areas that would benefit from additional guidance from the Commissioners,
16 and to answer questions that the Commissioners may have of the parties. As an action item for
17 the workshop, or afterwards, the parties would then confer on a schedule for the future phase(s)
18 of this proceeding. The parties propose filing a draft agenda for the Commission workshop at
19 least two weeks prior to the workshop and would further propose that ALJ Allwein and the
20 Commissioners provide feedback, if necessary, on any modifications to the agenda.

21 The parties have conferred on potential dates for the Commissioner workshop, focusing
22 on Tuesdays and Thursdays, and have identified August 20, 2020, as the only date that all parties
23 are available in July, August and September. We are continuing to look at additional dates that
