The Public Utility Commission of Oregon (Commission) will hold a Public Comment Hearing on Idaho Power Company's 2019 Integrated Resource Plan (IRP) on April 23, 2020. Due to the ongoing COVID-19 situation, the Commission will be conducting this Public Comment Hearing remotely. The Public Comment Hearing will consist of two parts using different technology and beginning at different times, as described below.

The Public Comment Hearing is an opportunity for customers and members of the public to offer comments to the Commissioners and Administrative Law Judge. Because the purpose of this hearing is to take comments from the public, Idaho Power will not make a formal presentation and there will be no dialogue with Commissioners. This event will be recorded and transcribed, and the transcription will become part of the record in the proceeding.

The Commission strongly encourages anyone with access to a computer to participate in the web-based portion (first part) of the Public Comment Hearing. To the extent possible, we seek to reserve the time for the telephone-based portion (second part) of the Public Comment Hearing for those who do not have access to a computer.
