These revisions add an international blocking section to QC's Exchange and Network Services Price List, for consistency and clarification. International Blocking Service is already available under Section 13.16 of the CenturyLink Operating Companies Tariff F.C.C. No. 11 to business and residence customers. A \$17.00 nonrecurring charge applies; there is no monthly charge.

The addition of International Blocking Service to the QC's Exchange and Network Services Price List is solely for the purpose of alleviating confusion about availability and to standardize the reference to International Blocking Service across all CenturyLink ILEC tariffs. No customers are impacted by these clarifying revisions.
