**JOINT UTILITIES' MOTION TO
CHANGE PROCEDURAL
SCHEDULE**

1 Pursuant to OAR 860-001-0420, Idaho Power Company, PacifiCorp, dba Pacific Power,
2 and Portland General Electric Company (collectively, the Joint Utilities) request that the
3 Administrative Law Judge (ALJ) change the procedural schedule in this matter as set forth
4 below. On October 16, 2020, the ALJ issued a ruling requesting that the parties work together
5 to reschedule the remaining procedural deadlines and submit a motion to change the procedural
6 schedule. The Joint Utilities have conferred with all parties to this proceeding (Public Utility
