The purpose of this update is to revise PGE's revenue requirement by approximately \$50,000 in order to align with Section 6a of the stipulation adopted through Commission Order No. 20-279. No other changes from PGE's October 14, 2020 revenue requirement filing have been made and the attached revenue requirement is consistent with the stipulation adopted in Order No. 20-279. PGE provides this revenue requirement as informational only and will file new tariffs consistent with Order Nos. 20-279 and 20-321 for Docket No. UE 370.
