The Alliance of Western Energy Consumers (“AWEC”) files this Notice of Intent to Request an Issue Fund Grant in Docket No. UE 377, pursuant to OAR § 860-001-0120 and the Fourth Amended and Restated Intervenor Funding Agreement (“IFA”), approved by the Oregon Public Utility Commission (“Commission”) in Order No. 18-020 (January 17, 2018).

1. On April 1, 2020, Portland General Electric Company (“PGE”) filed its 2021 Annual Power Cost Update Tariff. The Commission docketed the filing as UE 377.
2. UE 377 is an Eligible Proceeding for Issue Funds under Article 1(c)(iv) of the IFA. Accordingly, an Issue Fund Grant may be made for this proceeding under the IFA.
3. As required by Article 6.2 of the IFA, AWEC is filing this Notice of Intent at the time it files its Petition to Intervene this Docket.
4. As required by Article 6.2 of the IFA, this Notice of Intent is being served on each affected Participating Public Utility, all precertified organizations, and all parties identified on the service list for UE 377.

5. AWEC identifies the PGE Issue Fund Account as the account from which AWEC intends to request the Issue Fund Grant.

6. AWEC has been precertified under Articles 5.1 and 5.2 of the IFA and OAR § 860-001-0120(3)(b) as eligible to receive an Issue Fund Grant, by Commission Order No. 03-502, which was entered on August 21, 2003.
