(Docket No. ADV 1116/Advice No. 20-2) Corrects Typographical Error in Tariff.

STAFF RECOMMENDATION:

Approve Oregon Water Utilities - Mountain Lakes, Inc.s' (Company) Advice filing No. 20-2, requesting a correction to the Company's tariffs due to a typographical error in Schedule No. 1, Sheet 3. The new page would be effective for service rendered on and after June 1, 2020.

DISCUSSION:

Issue

Whether the Public Utility Commission of Oregon (Commission) should approve the Company's proposed correction to its tariff, Schedule No. 1, Sheet No. 3.

Applicable Law or Rule

The Commission may approve tariff changes if they are deemed to be fair, just, and reasonable. ORS 757.210. Tariff revisions may be made by filing revised sheets with the information required under the Commission's administrative rules, including OAR 860-022-0025. Filings that propose any change in rates, tolls, charges, rules, or regulations must be filed with the Commission at least 30 days before the effective date of the change. See ORS 757.220; OAR 860-022-0020.

Analysis

On April 29, 2020, the Company filed a request to correct a typographical error in its Schedule No. 1, Sheet No. 3 - Residential Monthly Base Rate. The Commission previously approved a base rate is \$33.00 per month, which the Company has been charging. As a result of the typographical error, the current tariff page lists the base rate as \$33.20 per month. This filing solely reflects the correction of the typographical error.

Conclusion

Staff reviewed the Company's filing and agrees that the correction is appropriate. The Company has been billing at the Commission-approved rates. The filing was submitted within 30 days before the effective date, as required by Commission rule.
