**JOINT STIPULATED
MOTION TO DISMISS**

Expedited Consideration Requested

1 Complainants Willamette Falls Paper Company (WFalls) and West Linn Paper Company
2 (WLP) and Defendant Portland General Electric Company (PGE) jointly move the Public Utility
3 Commission of Oregon (Commission) to dismiss with prejudice all claims raised in this docket.
4 WFalls and WLP’s claims center around two issues: (1) eligibility for long-term direct access
5 service; and (2) a request for waiver of the Commission’s rules regarding new load direct access.
6 In exchange for payment of all WLP’s outstanding retail electric charges due to PGE, the
7 settlement allows WFalls to receive long-term direct access service through WLP’s assignment of
8 its rights and delegation of its duties to WFalls, consistent with the terms and conditions of the
9 bilateral contract with PGE for long-term direct access. Therefore, WLP, WFalls, and PGE request
10 that the Commission dismiss all claims with prejudice and close this docket. **The parties request**
11 **expedited consideration because certain provisions of the settlement require that the case be**
12 **dismissed by December 31, 2020.**
