Referencing Advice No. 20-15**

Portland General Electric Company (PGE) submits this filing pursuant to Oregon Revised Statutes (ORS) 757.205 and 757.210 and Oregon Administrative Rule (OAR) 860-022-0025 and 860-022-0030 for filing proposed tariff sheets associated with Tariff P.U.C. No. 18, with an effective date of **September 1, 2020**:

Thirty Second Revision of Sheet No. 129-3
Thirteenth Revision of Sheet No. 129-5

This compliance filing establishes the Schedule 129 Transition Cost Adjustment Rate using the methodology approved at the August 25, 2020, OPUC Public Meeting. Customers with loads greater than one MWA choosing service under Schedule 485, 489, 490, 491, 492, or 495 during the September 2020 declaration window will be subject to the Schedule 129 Transition Cost Adjustment rate for the chosen term of service of either three or five years.

To satisfy the requirements of OARs 860-022-0025(2) and 860-022-0030(1), PGE provides the following responses:

OAR 860-022-0025 and 860-0022-0030 requires that PGE submit a statement of the tariff schedule change, the number of customers affected, the change in revenue, and the grounds supporting the change. The prices are limited to a number of eligible customers, all of whom may choose not to participate, therefore, it is unknown how many customers will make this election and the revenue change is unknown.
