**I. NOTICE OF WITHDRAWAL**

The Northwest & Intermountain Power Producers Coalition (“NIPPC”)<sup>1</sup> respectfully submits this Notice of Withdrawal of NIPPC’s Motion for Clarification or, in the alternative, Application for Reconsideration of Order No. 21-460 (“Motion”) submitted on January 21, 2022. NIPPC’s Motion sought clarification or reconsideration of an Oregon Public Utility Commission (the “Commission”) order related to PGE’s Notice of Intent to submit an affiliate bid in the 2021 Request for Proposals (“RFP”).<sup>2</sup> Recently, PGE filed a Notice of Withdrawal of its affiliate bid from the 2021 RFP.<sup>3</sup> PGE’s decision to withdraw its affiliate bid from the RFP moots NIPPC’s concerns raised

in its Motion for Clarification or Reconsideration and obviates the need for Commission action at this time. Therefore, NIPPC respectfully submits this Notice of Withdrawal of its Motion. However, if PGE later expresses intent to pursue another affiliate bid in this RFP, NIPPC reserves the right to seek clarification or other appropriate action by the Commission.

## II. CONCLUSION

For the above reasons, NIPPC respectfully submits this Notice of Withdrawal of its Motion for Clarification or, in the alternative, Application for Reconsideration of Order No. 21-460. However, NIPPC reserves the right to seek relief in the future if circumstances change.
