Dear Judge Lackey,

I write on behalf of representatives from CUB, AWEC, and Staff with a purely procedural question related to PGE's request for expedited consideration in its motion to strike, filed on October 28, 2021.

PGE proposes that any responses be due in five days. As PGE notes, CUB, AWEC, and Staff oppose the Company's request for expedited treatment.

CUB, AWEC, and Staff would appreciate guidance on how to proceed. We do not believe the Company will be prejudiced if parties are able to respond within the normal, non-expedited response window. However, we want to be efficient with the Commission's resources and do not want to delay our response should your honor find that expedited treatment is appropriate.

Is it feasible for the Commission to rule on the request for expedited treatment as a preliminary matter without ruling on the substance of the motion? CUB, AWEC, and Staff are open to any process you see fit. We are also happy to convene a conference if you feel that would help resolve this issue.

Thanks in advance for your consideration. I have copied attorneys for PGE, Staff, and AWEC to this email.
