This filing is being made to modify and standardize pricing amongst Canby’s existing Ethernet Transport Service offering capacities. The rate changes are predominately reductions, however there are a few instances where a rate is slightly increased. Additionally, this filing introduces new 2 Gigabyte thru 10 Gigabit Ethernet Transport Capacity options in 1 Gigabit increments for Month-to-Month, 3 Year Term, and 5 Year Term service terms. These new pricing and capacity options will afford customers the opportunity to purchase Ethernet Services at higher speeds.
