RE: <u>Docket No. UG 435</u>– In the Matter of NW NATURAL Request for a General Rate Revision - <u>Errata Filing</u>

In Staff's original filing, the summary table for Staff's revenue adjustments found in Staff/200, Fjeldheim/3 - Issue 1. Summary Chart of Proposed Staff Adjustments included two omissions for Staff depreciation expense adjustments associated with Confidential Staff Issue 300-6 (Test Year Plant – Additions) and Staff Issue 300-7 (NWN Errata Filing - Error Correction). In both instances, the summary table did not include the dollar figures for Staff's proposed depreciation expense adjustments. While the revenue requirement dollar amounts for Confidential Staff Issue 300-6 and Staff Issue 300-7 were correct in the original summary table and reflected the revenue sensitive impacts of the omitted depreciation adjustments, the individual and aggregate adjustment amounts for Staff's proposed expense adjustments in the summary table were incomplete. Despite the two omissions in the summary table for depreciation expense, the Staff revenue requirement model properly captured and calculated the effects of the depreciation adjustments, and the Staff revenue requirement model output remains unchanged. The changes to the summary table do not affect the outcome of the Staff revenue requirement model and is solely intended to provide a more accurate representation of Staff's proposed adjustments to NW Natural's rate filing.
