## UM 2207, 2208 and 2209 Wildfire Mitigation Plan Assessments

### Work Plan Update and Comment Period Notice

This announcement provides an update to the Wildfire Mitigation Plan analysis currently underway by OPUC Staff. The plan is augmented with delivery dates for Independent Evaluator reports, in addition to greater clarification regarding opportunities to comment on these reports and Staff memos; the originally intended Special Public Meeting is being canceled.

The comment period for stakeholders has been extended to provide written comments to any of the dockets as below by **Wednesday, May 31, 2023**; the IE report will be received and posted on **Tuesday, May 23, 2023**.

#### Work Plan Update

During late December, 2022 investor owned utilities filed their 2023 Wildfire Mitigation Plans. The OPUC has 180 days to evaluate these plans and either to approve or approve with conditions. On March 14, 2023 the OPUC hosted a [workshop](#) where the utilities presented the overviews of their plans. Since then, “deep dive meetings” into topic areas have been underway and are being complemented with information requests supporting the deep dives. This information is being incorporated into reports which the Independent Evaluator is preparing for each company.
