

PACIFICORP’S MOTION TO MODIFY
PROCEDURAL SCHEDULE
(Expedited Consideration Requested)

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp) respectfully requests that the Public Utility Commission of Oregon (Commission) issue an order suspending the procedural schedule in this docket. PacifiCorp, Commission Staff, the Oregon Citizens’ Utility Board, the Alliance of Western Energy Consumers, Calpine Solutions, LLC, Vitesse, LLC, Klamath Water Users Association/Oregon Farm Bureau Federation, and Sierra Club have developed a full settlement of all the issues in this docket, and suspension of the procedural schedule will allow for the filing of a settlement and supporting testimony. Because Staff and Intervenor Rebuttal testimony is due July 20, 2022, PacifiCorp requests expedited treatment of this motion in accordance with OAR 860-001-0420(6). PacifiCorp has contacted Commission Staff, the Oregon Citizens’ Utility Board, the Alliance of Western Energy Consumers, Calpine Solutions, LLC, Vitesse, LLC, Klamath Water Users Association/Oregon Farm Bureau Federation, NewSun Energy, and Sierra Club, and those parties do not oppose this motion. The settling parties intend to file the settlement and supporting testimony by August 3, 2022.
