**RE: UM 2236 PGE's Application for Authorization to Defer Costs Associated with Securing and Deploying Federal Grant Funds**

On March 23, 2022, Portland General Electric Company ("PGE") filed an Application for Authorization to Defer Costs Associated with Securing and Deploying Federal Grant Funds. Based on subsequent discussions with the Staff of the Public Utility Commission of Oregon ("Staff") and other stakeholders, PGE agreed to withdraw this request. While PGE will continue to pursue the strategy of seeking federal grant dollars related the Infrastructure Investment and Jobs Act (IIJA) on customer's behalf, we are no longer seeking recovery of the associated costs through deferred accounting. However, we do expect the effort of securing and utilizing IIJA grant dollars will be ongoing and long-term in nature and so we plan to include future forecasted expenditures within a future rate proceeding.

A Notice regarding the filing of this withdrawal has been provided to the parties on the UM 2236 service list.
