26 Professional Liability Fund Plan requirement.

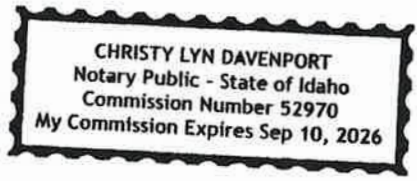
1 5. I agree, as a continuing obligation under UTCR 3.170(1)(f), to notify the  
2 Public Utility Commission of Oregon promptly of any changes in my status.


