Pursuant to the Administrative Law Judge’s Memorandum Revising Procedural Schedule issued on August 14, 2023, the Alliance of Western Energy Consumers (“AWEC”) submits the following Cross-Examination Statement for the evidentiary hearing to be scheduled in the above-referenced Docket. AWEC is the only party with contested issues and proposed Net Variable Power Cost adjustments that have not been resolved through settlement and the only party to whom Portland General Electric (“PGE”) responded in Sur-Rebuttal Testimony filed on August 10, 2023. AWEC has conferred with PGE and both parties have agreed to waive any evidentiary hearing on the remaining Net Variable Power Cost issues. Furthermore, PGE has indicated it does not object to AWEC’s hearing exhibits filed contemporaneously herewith.
