CAPO'S REQUEST FOR FINAL PAYMENT

Pursuant to HB 2475 (ORS 757.072), OAR 860-001-0860, and the Justice Funding Agreement adopted by the Oregon Public Utility Commission (Commission) in UM 2211 by Order 23-033 (February 7, 2023), the Community Action Partnership of Oregon (CAPO) files this request for final payment of \$14,962.5 in UE 416.

On May 9, 2023, CAPO filed its Request for a Justice Funding Case Grant together with a Proposed Budget. On June 6, 2023, the Commission case certified CAPO and approved its submitted budget by Order No. 23-197. On September 7, 2023, CAPO filed an amended budget which was approved in Order No. 23-341.

Attachment A itemizes the expenses, payees, and hourly rates for amounts to be reimbursed; It also demonstrates that the expenses are reasonable and directly attributable to issues and positions pursued on behalf of low-income customers, and consistent with our proposed budget.
