The public comment hearing is an opportunity for customers and members of the public to offer unsworn testimony to the Commissioners and Administrative Law Judge. The event will begin with brief presentations from the Administrative Law Judge and Staff to explain the rate case process. Because the purpose of this hearing is to take comments from the public, PGE and the other parties to the proceeding will not make formal presentations and the Commissioners will not take questions. The public comment hearing will be recorded

and transcribed. The transcript will become part of the public comment record in the proceeding.
