RULING

**DISPOSITION: STIPULATION, TESTIMONY AND EXHIBITS ADMITTED**

The parties filed motions to admit the jointly and individually filed stipulations, prefiled testimony, and exhibits with supporting declarations by their witnesses.<sup>1</sup> On October 4, 2023, the Small Business Utility Advocates filed a response to Staff’s motion to admit, objecting to the admission of exhibits unless all public comments were included with Staff’s testimony. Staff replied to SBUA’s response on October 5, 2023, amending its motion to admit to include one inadvertently omitted pre-filed exhibit and explaining that this exhibit contained the public comments SBUA believed to have been omitted. I note that the public comments made at the public comment hearing are included in the official transcript of that proceeding, which is also a part of the record of this docket and need not be appended to Staff’s testimony.

I find the testimony and exhibits offered by the parties and supported by declarations of the witnesses meet the standards for relevance as required by OAR 860-001-0450(1) and satisfy the requirements of OAR 860-001-0480. Additionally, I take official notice under OAR 860-001-0460(d) of PGE’s responses to Bench Requests 1-1 through 1-5, 2-1, 3-1 through 3-3, 4-1 through 4-3, and 5-1 through 5-7, and 5-9.
