Pursuant to Section 7.3 of the Fifth Amended and Restated Intervenor Funding Agreement (“IFA”) approved by the Oregon Public Utility Commission (“Commission”) in Order No. 22-506 (Dec. 29, 2022), the Alliance of Western Energy Consumers (“AWEC”) hereby requests partial payment of AWEC’s Issue Fund Grant in Docket No. LC 82 in the amount of ~~\$14,883.35~~\$9,922.22.

On April 17, 2023, AWEC filed a Proposed Budget and Request for Issue Fund Grant in Docket No. LC 82 in the amount of \$40,000. On April 21, 2023, the Commission approved an Issue Fund Grant for AWEC in the amount of \$40,000 by Order No. 23-150. At this time, AWEC requests that the Commission authorize partial payment of AWEC’s Issue Fund Grant in Docket No. LC 82 in the amount of ~~\$14,883.35~~\$9,922.22 from the 2023 PacifiCorp Issue Fund. AWEC’s expenses are shown in Confidential Exhibit A.

This Request for Payment satisfies the requirements of the IFA as follows:

Section 7.3(a) – The itemized expenses, payees, and hourly rates are attached as Confidential Exhibit A.

Section 7.3(b) – AWEC has been an active participant in this Docket. AWEC reviewed the filings in this docket, conducted discovery, and filed comments in

this Docket. The expenses included in Confidential Exhibit A are reasonable and directly attributable to AWEC's participation in LC 82.

Section 7.3(c) – The Commission approved AWEC's proposed budget on April 21, 2023. In addition, AWEC used its own funds to pay for at least 20% of the Eligible Expenses as required by Section 6.5 of the IFA.

Section 7.3(d) - This Request for Payment constitutes a Partial Request for Payment in this Docket.

Section 7.4 – All of the expenses included in Exhibit A are Eligible Expenses as defined in Section 7.4 of the IFA because they relate to services provided or expenses incurred by AWEC's outside legal counsel and expert witnesses. Relevant non-privileged documents substantiating the Eligible Expenses in Confidential Exhibit A are available for Commission audit, if requested, pursuant to Section 7.10 of the IFA.

The IFA provides that the granting of an Issue Fund Grant “shall constitute a binding obligation on the Commission to order reimbursement of Eligible Expenses.” IFA § 6.5. Likewise, the intervenor funding rules adopted by the Commission provide that “[t]he terms of an [intervenor funding] agreement are binding on all organizations seeking a grant under that agreement and will be followed by the Commission in administering the agreement.” OAR § 860-001-0120(2). AWEC has satisfied the terms of the IFA and respectfully requests that the Commission approve partial payment of AWEC's Issue Fund Grant in the amount of ~~\$14,883.35~~\$9,922.22 in the manner described above within 30 days of receiving this Request for Partial Payment, as provided in Article 7.6 of the IFA.

Upon payment of this Request for Partial Payment of Issue Fund Grant, the balance of AWEC's LC 82 Issue Fund Grant will be ~~\$25,116.65~~\$30,077.78.
