Application for Designation as an Eligible Telecommunications Carrier and Eligible Telecommunications Provider, and Request for Certain Waivers. MOTION TO WITHDRAW APPLICATION

Pursuant to OAR 860-001-0420, Tempo Telecom, LLC ("Tempo" or "Company") respectfully submits this Motion to Withdraw its Application for Designation as an Eligible Telecommunications Carrier ("ETC") and Eligible Telecommunications Provider, and Request for Certain Waivers ("ETC Application"). On July 27, 2023, Tempo filed its ETC Application with the Public Utility Commission of Oregon ("Commission"), the subject of the abovecaptioned docket. Since the Company filed its ETC Application, Tempo and the parties, Commission Staff ("Staff") and the Citizens' Utility Board of Oregon ("CUB"), held several workshops and settlement conferences, and engaged in discovery.

Tempo now seeks to withdraw its ETC Application, without prejudice to its right to file a new application in the future. Tempo asks the Commission for approval to withdraw the Company's ETC Application and close the above-captioned docket.

In support of this Motion, Tempo states:

1. Tempo is committed to the Lifeline program and serving the needs of eligible, low-income customers. Tempo hopes to eventually expand its Lifeline operations to Oregon. 2. Tempo appreciates the engagement from Staff and CUB in this proceeding. The Company expects that it will submit an application for ETC designation in Oregon again at a later date, and looks forward to working with stakeholders in the future.

3. Tempo has determined that the best course of action at this time is to withdraw its ETC Application and close this proceeding. The company has conferred with the parties to this proceeding, Staff and CUB, and neither party opposes this Motion.

Accordingly, Tempo moves to withdraw its ETC Application, without prejudice to its right to file a new ETC Application in the future, and requests that the Commission close this docket.
