1 INTERCONNECTION PROJECT UPDATE

2 On May 10, 2024, Administrative Law Judge (ALJ) Sarah Spruce ordered PacifiCorp to
3 file “an update with the Commission upon completing the Commissioning Document Review”
4 milestone in its project to complete the interconnection of the facilities of Green Solar LLC (Green
5 Solar) pursuant to the parties’ Interconnection Agreement.¹

6 At the prehearing conference on May 15, 2024, PacifiCorp indicated that it had completed
7 all the interconnection work and the only remaining milestone for PacifiCorp was the witness test,
8 which would allow PacifiCorp to complete the Commissioning Document Review milestone.
9 PacifiCorp and Green Solar have mutually agreed to schedule the witness test for Thursday,
