**PACIFICORP’S INTERCONNECTION  
PROJECT UPDATE**

1           On May 30, 2024, Administrative Law Judge (ALJ) Sarah Spruce ordered that “the parties  
2 shall file status updates as each remaining milestone is completed, as well as an overall status  
3 update no later than June 7, 2024.”<sup>1</sup>

4           PacifiCorp notified Green Solar LLC (Green Solar) that, as of June 1, 2024, Green Solar  
5 has met all the requirements for operating its community solar project and may commence  
6 commercial operations on the PacifiCorp system. PacifiCorp sent this clearance for commercial  
7 operations once all the remaining milestones in Attachment 3 to the parties’ Interconnection
