Yesterday, Idaho Power Company (“Idaho Power”) filed a Proposed Procedural Schedule on behalf of Idaho Power, Staff of the Public Utility Commission of Oregon (“Staff”), and the Oregon Citizens’ Utility Board (“CUB”). The parties have continued to confer on the Proposed Procedural Schedule and submit additional changes.
