**MOTION TO SUSPEND
PROCEDURAL SCHEDULE**

Expedited Consideration Requested

In accordance with OAR 860-001-0420, Idaho Power Company (Idaho Power or the Company) respectfully submits this Motion to Suspend Procedural Schedule. All parties to this case (Idaho Power, Staff, the Oregon Citizens' Utility Board (CUB), Community Energy Project (CEP), J. R. Simplot Company (Simplot), and the Oregon Irrigation Pumpers Association, Inc. (OIPA)) have reached a settlement in principle that resolves an issue in this case that was raised by OIPA following the execution and filing of the First and Second Partial Stipulations, and is the only remaining disputed issue. The parties request a suspension of the current procedural schedule to allow time to finalize and execute a settlement stipulation and supporting testimony. The parties anticipate filing a Third Partial Stipulation and supporting joint testimony by Friday, June 14, 2024.

OIPA's objection to the First Partial Stipulation is currently due on Friday, June 7, 2024. Therefore, in accordance with OAR 860-001-0420(6), Idaho Power requests expedited consideration of this Motion. Idaho Power has conferred with Staff, CUB, CEP,

Simplot, and OIPA. All parties support this Motion and the request for expedited consideration.
