DISPOSITION: WAIVER REQUESTS GRANTED; PROCEDURAL SCHEDULE ADOPTED

On May 16, 2024, Idaho Power Company, on behalf of Commission Staff, Oregon Citizens' Utility Board, Community Energy Project, and J.R. Simplot Company (collectively, Stipulating Parties), filed a motion to admit the first partial stipulation and a request for waiver of OAR 860-001-0350(7). The Stipulating Parties noted they sought to file the stipulation immediately to notify the Commission and interested parties that they had resolved all but one issue in this proceeding. That motion indicated an intent to file joint testimony supporting the first partial stipulation on or around May 24, 2024. Responses to the motion to admit the first partial stipulation were due on May 23, 2024. No responses to the motion were filed. Idaho Power filed joint testimony supporting the first partial stipulation on May 24, 2024.

On May 17, 2024, the Stipulating Parties filed a motion to admit the second partial stipulation and a request for a waiver of OAR 860-001-0350(7). The Stipulating Parties noted they sought to file the stipulation immediately to notify the Commission and interested parties that they had resolved the final issue in this proceeding. The May 17 motion indicated an intent to file joint testimony supporting the second partial stipulation on or around May 28, 2024. Responses to the May 17 motion were due on May 24, 2024. No responses to the motion were filed.

I grant the Stipulating Parties' request to waive OAR 860-001-0350(7) as it relates to the first and second partial stipulations for good cause shown.

On May 28, 2024, Idaho Power filed a proposed schedule for this matter on behalf of all parties.

I adopt the procedural schedule as proposed by the parties and modified to include additional milestones as follows:
