**NOTICE OF USE OF GENERAL
PROTECTIVE ORDER**

1 Idaho Power Company (“Idaho Power”) hereby provides notice that it anticipates
2 designating information to be produced or used in this docket as protected under the
3 Commission’s General Protective Order No. 23-132 (“GPO”). Idaho Power expects to
4 soon file a Motion for Modified Protective Order to protect highly confidential
5 information.

6 Idaho Power will soon be filing a general rate case. In accordance with
7 OAR 860-022-0019(2)(a), the general rate case filing must include all the information
8 from the most recent version of the Standard Data Requests for Energy Rate Cases
9 (“Standard Data Requests”). In addition, OAR 860-022-0019(2)(b) requires the
10 Company to submit a motion for a general protective order or modified protective order
11 under OAR 860-001-0080, if necessary, for the release of information under OAR 860-
12 022-0019(2)(a). Here, the Company’s responses to the Standard Data Requests
13 include confidential information. In addition, Idaho Power anticipates that Staff and
14 intervenors will seek to discover confidential business information in the discovery
15 process. The Commission’s rules authorize Idaho Power Company to seek reasonable
16 restrictions on discovery of trade secrets and other confidential business information.
17 See OAR 860-001-0080 and ORCP 36(C)(1) (providing protection against unrestricted
18 discovery of “trade secret[s] or other confidential research, development, or commercial

1 information”). Issuance of a protective order will facilitate the production of relevant
 2 information and expedite the discovery process. The GPO is available at:
 3 <https://apps.puc.state.or.us/orders/2023ords/23-132.pdf>. Other parties to the
 4 proceeding may seek access to the protected information under the terms of the GPO
 5 using the signatory pages in Order No. 23-132.

6 The individuals listed in the table below are employees of Idaho Power or Idaho
 7 Power’s counsel and are identified for purposes of accessing information designated as
 8 protected by Idaho Power within the docket. Idaho Power will provide updates to this
 9 table during the course of the proceeding to ensure that it accurately identifies the
 10 employees who should have access.
