SUBJECT: SUNRIVER WATER LLC:

(Docket No. ADV 1591/Advice No. 24-1)

Implements a Commodity Power Cost Adjustment.

STAFF RECOMMENDATION:

Staff recommends that the Commission approve Sunriver Water LLC's (Sunriver or Company) filed tariff sheets, which implement a Commodity Power Cost Adjustment (CPCA), to become effective for service rendered on and after March 4, 2024.

DISCUSSION:

Issue

Whether the Commission should allow Sunriver's filed tariff sheets to become effective.

Applicable Rule or Law

Under ORS 757.205(1)-(2), a rate-regulated water utility must file schedules showing all rates, tolls, and charges for any service performed by it within the state and all rules and regulations that in any manner affect its rates. Pursuant to ORS 757.210, the Commission may approve tariff changes if they are deemed to be fair, just, and reasonable. Tariff revisions may be made by filing revised sheets with the information required under the Commission's administrative rules, including OAR 860-036-2010.

Pursuant to ORS 757.220, filings that propose any change in rates, tolls, charges, rules, or regulations must be filed with the Commission at least 30 days before the effective date of the change.

Analysis

Background

Sunriver is a rate- and service-regulated water utility serving approximately 5,000 customers in the vicinity of Sunriver, Oregon. With this filing, Sunriver proposes to implement a CPCA, as allowed under Schedule 9 of the Company's current tariff. The filing was submitted on February 2, 2024, which is more than 30 days prior to the proposed effective date of March 4, 2024, in line with applicable requirements.

Analysis

Schedule 9 of Sunriver's current tariff is an "Automatic Adjustment Clause" as defined in ORS 757.210. This schedule enables Sunriver to revise its rate schedules to reflect increases or decreases in the Company's purchased commodity power cost. The adjustments may be shown in or incorporated directly into the applicable rate schedules. If the Company elects to file for power cost increases, it is also obligated to file for decreases in power costs. The present filing represents Sunriver's first implementation of the Schedule 9 CPCA.

With the present filing, Sunriver proposes to add a CPCA of \$0.05 per unit to its tariff under Schedule 1 (Residential, Commercial, and Multi-Family Metered Rates), Schedule 3 (Irrigation Metered Rates), Schedule 5 (Golf Course Irrigation Rates), and Schedule 6 (Rates for Commercial Water Haulers). Sunriver's water is measured in units of 1,000 gallons.

The Company submitted, and Staff reviewed, workpapers calculating the CPCA at \$0.05 per unit. The Company's calculation is based on the per-unit difference in power cost between 2021 and 2024, as summarized in the following table.

\$0.05 Difference

Staff performed the calculation differently but arrived at the same result of \$0.05 per unit. Staff's calculation uses figures from the Company's most recent rate case (UW 186) to first calculate the amount of power cost embedded in current rates. Staff then calculated the new per-unit power cost using UW 186 consumption and the

estimated 2024 power cost of \$93,044, which was provided by Sunriver's electric provider, Midstate Electric Cooperative, Inc. This methodology is similar to that used to calculate the CPCA for Avion Water Company as shown in Docket No. ADV 1579. Staff's calculation also results in a CPCA adjustment of \$0.05 per unit, as summarized in the following table.

The \$0.05 CPCA adjustment is added to the Company's variable rates on the tariff schedules cited previously. The adjustment is incorporated directly into the Company's variable rates, as allowed by the tariff. This filing results in the following rate changes.

For a typical Schedule 1 customer (which includes residential customers) using 6.61 units of water per month, this rate change would increase the monthly bill by approximately \$0.33, or 1.1 percent.

The Company has reviewed a draft of this memo and noted no concerns.

Conclusion

Staff reviewed the Company's cost documentation and proposed calculation methodologies. Staff finds that Sunriver's requested CPCA rates are allowed under Schedule 9 of the Company's current tariff and should be allowed to become effective.

SCHEDULE NO. 6 RATES FOR COMMERCIAL WATER HAULERS

AVAILABLE: To commercial water haulers where the Utility's facilities and excess capacity exist.

Determination of adequacy of facilities and capacity is in the sole discretion of the Utility.

Each commercial water truck must be inspected by the Utility and be equipped with a suitable

hydrant meter, suitable backflow prevention devices, and a fire hydrant wrench.

APPLICABLE: To all commercial water haulers.

RATE FOR COMMERCIAL WATER HAULERS

\$2.25 per 1,000 gallons

SPECIAL PROVISIONS:

- 1. Truck meters must be presented at the Utility's office between the 1st and the 5th of each month. Bills for service are due in accordance with the tariff. Failure to present meter in accordance with this provision will be considered grounds for termination of service under Rule 19 of this Tariff.
- 2. Commercial water haulers detected not using meters or proper equipment may be denied service for one month for the first offense, and denied service completely for a second offense.
- 3. Commercial water haulers shall fill only from designated hydrants at designated times that have been determined by the Utility to have excess capacity. Failure to comply with this requirement will be considered grounds for termination of service.
- 4. Continued use of the Utility's facilities following termination of service shall be considered theft of services under OAR 860-036-1590.
