# **Re:** In the Matter of Portland General Electric Company, Petition of Public Convenience and Necessity (Docket No. PCN 6).

Portland General Electric (PGE) has proposed to build a transmission line that is part of the Tonquin project in Clackamas County, called the Rosemont-Wilsonville Line, and PGE identified you as an individual or entity with an interest in land for which the utility may need to acquire an interest. You may have received a letter from PGE or PGE's attorneys about this.

The Oregon Public Utility Commission (PUC) will investigate PGE's petition for a certificate of public convenience and necessity (CPCN) related to the Rosemont-Wilsonville Line through a contested case process which has been assigned the docket PCN 6. If the CPCN petition is granted, PGE will be able to condemn land to construct this transmission line.

Because PUC proceedings may be new to you, I wanted to let you know of some upcoming events related to the Commission's review of this project as well as inform you on how you can participate in the Commission's decision-making process. First, all public items related to this docket will be posted on the PUC's website. To access the PCN 6 docket, go to this website: <u>https://www.oregon.gov/puc/edockets/Pages/default.aspx</u>, click on "by docket number," enter PCN 6 in the text field, and click "next." You will be able to see pertinent information about the case, including all filings from parties as well as from the assigned Administrative Law Judge and the Commission.

The PUC will also consider a request from PGE to begin reviewing the CPCN petition before the land use permits are issued, which requires a waiver of certain Commission rules. The PUC's consideration of this request will occur at a public meeting on June 11, 2024, starting at 9:30 a.m. There will be an opportunity for members of the public to provide oral comment before the Commission makes a decision on PGE's request. Written comments will also be considered by the Commission and are requested to arrive by 12:00 p.m. on June 7, 2024. The Administrative Law Judge assigned to PCN 6 will hold a prehearing conference related to this docket on June 13, 2024, at 10:00 a.m. via Zoom video conference. This event is for parties and those interested in becoming a party to discuss procedural issues related to this docket, including this matter's schedule.

Additionally, I will hold a training for members of the public via Zoom, on July 9, at 1:30 p.m. The purpose of this training is to discuss participating in PUC contested cases and to answer questions about how to participate in PCN 6.

Any member of the public may participate in this contested case proceeding in a variety of ways. The most involved way to participate is to intervene as a party in this docket. This level of participation is best accomplished with an attorney representing you, however individuals can represent themselves in Commission proceedings. The Commission has rules governing the intervention process, which can be found at OAR 860-001-0300: <a href="https://secure.sos.state.or.us/oard/viewSingleRule.action?ruleVrsnRsn=220511">https://secure.sos.state.or.us/oard/viewSingleRule.action?ruleVrsnRsn=220511</a>. I will discuss intervention at the training mentioned above.

You may also submit written comments or attend a public comment hearing where you can present your views on the proposal to the Commission. These comments are included as evidence in the proceedings, however providing public comment does not involve any further obligation to participate to the extent that a party would.

Lastly, you may also track the docket as an interested person. This will enable you to receive an email every time something new is posted to the PCN 6 docket. To become an interested person, you should send an email to <u>puc.hearings@puc.oregon.gov</u> with your contact information and ask to be added to the PCN 6 interested person list.

Details and more information regarding the prehearing conference, training, and public comment hearing will be posted in the PCN 6 docket in the near future. Please do not hesitate to contact me if you have any questions about how to participate in PCN 6 at <u>nolan.moser@puc.oregon.gov.</u>

Individuals or entities unable to attend the prehearing conference may submit written materials for my consideration by 3:00 p.m. on June 12, 2024.

#### NOTICE OF CONTESTED CASE RIGHTS AND PROCEDURES

Oregon law requires state agencies to provide parties written notice of contested case rights and procedures. Under ORS 183.413, you are entitled to be informed of the following:

**Hearing:** The time and place of any hearing held in these proceedings will be noticed separately. The Commission will hold the hearing under its general authority set forth in ORS 756.040 and use procedures set forth in ORS 756.518 through 756.610 and OAR Chapter 860, Division 001. Copies of these statutes and rules may be accessed via the Commission's website at <u>https://www.oregon.gov/puc/Pages/default.aspx</u>. The Commission will hear issues as identified by the parties.

**Right to Attorney:** As a party to these proceedings, you may be represented by counsel. Should you desire counsel but cannot afford one, legal aid may be able to assist you; parties are ordinarily represented by counsel. The Commission Staff, if participating as a party in the case, will be represented by the Department of Justice. Generally, once a hearing has begun, you will not be allowed to postpone the hearing to obtain counsel.

**Notice to Active Duty Servicemembers:** Active Duty Servicemembers have a right to stay these proceedings under the federal Servicemembers Civil Relief Act. For more information contact the Oregon State Bar at 800-452-8260, the Oregon Military Department at 503-584-3571 or the nearest United States Armed Forces Legal Assistance Office through <u>http://legalassistance.law.af.mil</u>. The Oregon Military Department does not have a toll free telephone number.

Administrative Law Judge: The Commission has delegated the authority to preside over hearings to Administrative Law Judges (ALJs). The scope of an ALJ's authority is defined in OAR 860-001-0090. The ALJs make evidentiary and other procedural rulings, analyze the contested issues, and present legal and policy recommendations to the Commission.

**Hearing Rights:** You have the right to respond to all issues identified and present evidence and witnesses on those issues. *See* OAR 860-001-0450 through OAR 860-001-0490. You may obtain discovery from other parties through depositions, subpoenas, and data requests. *See* ORS 756.538 and 756.543; OAR 860-001-0500 through 860-001-0540.

**Evidence:** Evidence is generally admissible if it is of a type relied upon by reasonable persons in the conduct of their serious affairs. *See* OAR 860-001-0450. Objections to the admissibility of evidence must be made at the time the evidence is offered. Objections are generally made on grounds that the evidence is unreliable, irrelevant, repetitious, or because its probative value is outweighed by the danger of unfair prejudice, confusion of the issues, or undue delay. The order of presenting evidence is determined by the ALJ. The burden of presenting evidence to support an allegation rests with the person raising the allegation. Generally, once a hearing is completed, the ALJ will not allow the introduction of additional evidence without good cause.

**Record:** The hearing will be recorded, either by a court reporter or by audio digital recording, to preserve the testimony and other evidence presented. Parties may contact the court reporter about ordering a transcript or request, if available, a copy of the audio recording from the Commission for a fee set forth in OAR 860-001-0060. The hearing record will be made part of the evidentiary record that serves as the basis for the Commission's decision and, if necessary, the record on any judicial appeal.

**Final Order and Appeal:** After the hearing, the ALJ will prepare a draft order resolving all issues and present it to the Commission. The draft order is not open to party comment. The Commission will make the final decision in the case and may adopt, modify, or reject the ALJ's recommendation. If you disagree with the Commission's decision, you may request reconsideration of the final order within 60 days from the date of service of the order. *See* ORS 756.561 and OAR 860-001-0720. You may also file a petition for review with the Court of Appeals within 60 days from the date of service of the order. *See* ORS 756.610.
