


United States Cellular Corporation (“USCC”) and RCC Minnesota, Inc. (“RCC”) respectfully move the Oregon Public Utility Commission (“Commission”) to enter the Commission’s standard protective order in this proceeding. On July 15, 2005, USCC and RCC filed information in this docket that is proprietary and confidential to USCC and RCC, respectively, and would, if it were made available to the public, have actual and potential commercial value to USCC’s and RCC’s competitors. USCC and RCC filed the information under seal and committed to move for this protective order so that limited disclosure of USCC’s and RCC’s confidential information could be made to the parties to the docket under the terms of the Commission’s standard protective order. Because the Commission has required the filing of information that is normally held by USCC and RCC to be proprietary or confidential, it is appropriate that the Commission’s standard protective order be issued and that disclosure of such information be made only pursuant to the protective order.

Therefore, USCC and RCC respectfully request that the administrative law judge issue the standard protective order for use in this proceeding pursuant to OAR 860-01200035(k).



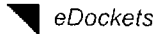
