MOTION TO MODIFY PROCEDURAL
SCHEDULE

15 Pursuant to OAR 860-013-0031, staff of the Public Utility Commission of Oregon
16 (“staff”) moves the administrative law judge to modify the procedural schedule in the above-
17 captioned dockets to allow an additional two days, until Friday, July 20, 2007, for the parties to
18 prepare and file their reply briefs. Counsel for staff has contacted all of the parties that filed
19 opening briefs in these matters, and none of them object to this request. Because the due date
20 for the briefs is tomorrow, staff requests expedited consideration of this motion.

21 The reply briefs are currently due on July 18, 2007. Oral argument is scheduled in this
22 matter for August 9, 2007. If the due date for the reply briefs is moved to July 20, 2007, the
23 Commission and administrative law judge will still have 13 business days to review the briefs
24 and prepare for the oral argument.
