**NOTICE OF PUBLIC  
MEETING**

On Monday, March 13, 2006, the Public Utility Commission of Oregon (Commission) will hold a public meeting to address issues related to Portland General Electric Company (PGE). The meeting will be held at 10:00 a.m., in the main hearing room at the Commission building, 550 Capitol Street. NE, Salem, Oregon.

Specifically, the Commission will hear responses to the Staff report presented on March 2, 2006, regarding issues surrounding PGE taxes and trading activity while owned by Enron. At the March 2 meeting, which was digitally recorded and posted on the Commission web site, certain items discussed were related to the merits of issues in the pending contested case proceedings in the above referenced dockets. Notices of *ex parte* communications were issued to parties in those dockets.

This notice is issued in anticipation of further discussion of related issues at the March 13, 2006, meeting. Without such notice, such discussion would constitute an *ex parte* communication under Commission rules. *See* OAR 860-012-0015. The meeting will be digitally recorded and posted on the Commission web site. Parties will have ten days to file a written rebuttal of any facts or contentions addressed at the meeting relating to issues pending in these dockets, with service on the parties of record in the relevant proceeding.
