Please find the following revisions to Monitor Cooperative Telephone Company's Tariff P.U.C. Or. No. 3, Access Service.

10th Revised Sheet Nos. 1, 5 9th Revised Sheet Nos. 4, 6	4

This filing is made in compliance with the Federal Communication Commission's (FCC) Order 20-143; Part 51 – Interconnection; Subpart M – 8YY Transition; §51.909 Transition of rate-of-return carrier access charges; Step 3. The FCC Order further established a three step glidepath reduction to a uniform, nationwide toll free database query rate. Step 3 requires interstate and intrastate originating End Office Access Service rate elements for Toll Free Calls to be reduced by one-half. It also requires the rates for intrastate and interstate Toll Free Database Query Charges to be reduce by one-half to the transitional rate of \$0.0002 per query set forth in paragraph (o)(2) of 47 CFR §51.909. Monitor proposes a reduction to the required rate level.

It is requested that this filing become effective July 1, 2022.
