Frontier Communications Northwest Inc. (Frontier) hereby submits for electronic filing the original and a redlined copy of the revised tariff sheets for the Network Access Service Tariff P.U.C. OR. No. 18.

The purpose of this filing is to introduce Frontier OneVoice bundled service. The filing was originally prepared as a one day notice filing in the Statewide Price List, however, in discussions with staff, a new bundle of services must first be filed in the tariff with 30 day notice and then the company must file a petition to price list the bundle and do another filing to move it to the Statewide Price List. An LSN Form 260 is included with this filing.

The rate for this bundle of services does not exceed the total of the individual tariffed rates for the service components of the bundle.
