**RE: Advice No. 18-2 – Tariff Housekeeping**

In compliance with Oregon Revised Statutes 757.205 and Oregon Administrative Rules 860-036-2010, Oregon Water Utilities – Mountain Lakes, Inc. (OWU-ML) submits for filing a revised tariff page correcting a typo in the original tariff page. The requested effective date is October 26, 2018. The correction of the typo is described below:

*First Revision of Sheet No. 3 of Tariff Set No. 4 – the monthly residential base rate approved by the Commission is \$33.00 per month, not \$33.20 per month. This typo was generated in OWU-ML's most recent tariff update.*

Please note that OWU-ML has continued charging customers the correct tariff amount of \$33.00 per month, not the typo amount. This filing solely reflects the correction of the typo and not a rate change; therefore, there are no revenue changes associated with this filing.
